Construction on Sauvie Island May Delay Traffic

On September 6th and 7th the girders (supports) for the Reeder Road bridge over Dairy Creek on Sauvie Island will be installed. This will be a dramatic visual event in the multi-million dollar Sturgeon Lake Restoration Project!

Here's what will happen: Ten pre-cast, 96-foot long concrete girders will be brought in by truck and set into place using a pair of cranes. When the girders are being delivered, there may be traffic delays. The contractor, Elting Northwest, anticipates only short delays as the trucks maneuver trailers carrying the girders into place. Flaggers will be present to manage traffic. We ask that motorists avoid the area, if at all possible, during this window of construction. Crews anticipate completion of this part of the project by the end of the day on Friday September 7th. The overall bridge project will continue till the end of September.

During this phase of the construction, all questions should be directed to Jim Cathcart, District Manager with West Multnomah Soil & Water Conservation District, 503.803.7750, and jim@wmswcd.org.

Since July 2nd, Elting Northwest Inc., has moved 4,000 cubic yards of soil to build an embankment off the side of the existing roadway. This created a new pathway for the road that winds around the site of the future bridge. This two-lane, paved bypass road will keep traffic flowing throughout the project, except when construction equipment needs access. The speed limit is reduced from 45 mph to 25 through the construction

zone. The District has secured a variable message sign, which is installed at the east end of the Sauvie Island bridge, to alert motorists of possible delays at the construction site. Construction is proceeding smoothly and work on the bridge is expected to wrap up around September 30th.
