From our Neighbor Jim Emerson on Old Germantown Road

Thank you and the whole "crew" at SRN for keeping the Ridge Runner both running and meaningful ! I found Michael Baker's poem especially powerful since there are also western red cedars dying in our little Abbey Creek valley, much to our dismay. He refers to being here 15 years, and I wonder if he - or anyone else - would like to have a copy of my weather records for my location, which go back to 1986.

We're on the BPA Portland Area Precipitation Network, reporting monthly since then. There are 28 metro-area stations (volunteers) grouped by sector: NW, N and NE, SE, SW, and Clark County. There are only two in all of NW ! - ours and one in Gales Creek. Or I guess since Judy died I should say, 'mine and ...'. I haven't adapted to the singular form yet !

The emphasis has been on rainfall totals by month, but I've also noted annual highs and lows with dates, days of 90 degrees or more, first and last frosts, and for several years now, monthly highs and lows plus average temperatures. The main data is on just two 8.5 x 11 sheets, so it's not overwhelming as long as someone can see my small handwriting.

NW Cornelius Pass Road Reopened to Traffic

NW Cornelius Pass Road reopened to traffic [on Tuesday evening 9/30/2020], after an 11-week closure to complete safety improvements between Highway 30 and NW Skyline Blvd. For information on the safety improvements, visit: www.multco.us/cornpass.

No additional road closures or lane closures are planned. For the next two weeks the contractor will be removing construction signs and completing landscaping work outside of the roadway. A temporary traffic signal at Highway 30 and NW Newberry Road will be removed.

Multnomah County thanks road users for their patience during the closure. The Oregon Department of Transportation will be taking jurisdiction for the road between Highway 26 and Highway 30 by early 2021. For information on the transfer, visit [ODOT's website](#).

The West Multnomah Soil & Water Conservation District (WMSWCD) Board of Directors will be meeting for a two-part Board Retreat held via Zoom on Wednesday, October 7th, beginning at 6:00 p.m. and Friday, October 9th, beginning at 3 p.m. The public is welcomed to all District board meetings, and the meeting agenda allows for time for public comment.

The agenda includes a review of the Long-Range Business Plan Update (LRBP) information gathering process, a presentation and discussion of draft revised mission and vision statements, an equity lens review of these statements, further refinement of the mission and vision statements and a decision to adopt finalized mission and vision statements, and a discussion to gather input on draft District goals for the next 5 years (2021-2025). The Long-Range Business Plan is a strategic planning document that guides the scope of the District's conservation work and the necessary financial sustainability and organizational health to implement this work for the next 5 years (2021-2025). The agenda can be modified by the Board of Directors at any time during the meeting.

Any person may attend the meeting and make public comment by via Zoom. A conference ID number and/or link will be required to access the zoom meeting. Interested participants may request the meeting invite information by emailing info@wmswcd.org with the subject line "Request for Conference ID" or by calling 503-238-4775 and leaving a voicemail message at extension 100, no later than 5:00 p.m. on Tuesday, October 6, 2020. The Board of Directors typically meets on the third Tuesday of the month at 6:00 p.m., and due to COVID-19 restrictions, in lieu of meeting in-person, meetings will be held virtually or via conference call until further notice.
